



Dear Members & Applicants:

For renewing members, complete and submit this form to the Club Secretary listed on the form **by August 31, 2025**. Payment may be made via PayPal, check or money order.

As a club, we depend on our members to support our activities so that we can be successful. In order for our club to grow, we need members to participate in decisions involving our future by attending club meetings, participating and helping with trials and supporting seminars or fun events.

The main sources of funding for this nonprofit organization are hosting agility trials and payment of membership dues. These funds are used to cover the cost of rent as well as for field and equipment maintenance and purchase of needed equipment and supplies. Other activities such as fun matches, lessons and dog training may be employed to contribute to fund raising.

In order to maintain membership in good standing, an individual must attend a minimum of one show and/or club special project per year. We also ask all members to participate in the club by volunteering at DOI trials, serving on the board, or participating in events at the training field. PLEASE VOLUNTEER! THE CLUB CANNOT EXIST WITHOUT EVERYONE'S PARTICIPATION.

Benefits of membership:

- All members receive 24/7 access to the DOI field (subject to availability).
- Priority access to all classes at the Zellwood field.
- Discounts on classes taught at the DOI field.
- Title plaques for USDAA and AKC agility titles, and
- An invitation to the annual Holiday Party.
- Those members who actively participate in the club are eligible for participation on DOI's DACOF team(s) with trial-ready dogs.

There are two levels of membership. The cost of each reflects the level of participation expected of club members. Both levels of membership require submission with the appropriate fee (\$) and a waiver (includes guest activity) to be signed and submitted to the Club Secretary. We are excited to have you join us for training, companionship and fun with your four-legged friends and club members.

Gold Membership

This level reflects the full charter of the organization. DOI is a club and, as such, members are expected to share the benefits as well as the burdens required to maintain the organization. This membership level is the more interactive membership, hence a discount that benefits the activity.

Cost: \$50/year

Requirements: During the year attend one club meeting and participate in at least one club sponsored activity (i.e. work at a trial or other club activity, become a Board member, serve as Training Director or become Field Manager.)

Benefits: Field use 24/7 with priority over Silver members for field scheduling should that situation occur.

Silver Membership

This level is for those individuals who do not plan to participate in fund raising or club maintenance activities, hence the higher cost on a yearly basis.

Cost: \$100/year

Requirements: Attend a minimum of one show or activity during the year.

Benefits: Field use 24/7 unless occupied by a Gold level member or previously scheduled event.

General Information Regarding Field Use

Hours of Operation:

- 24 hours per day, 7 days per week, except when reserved for classes or special events. **Please be aware of Orange County noise ordinances.**

Who May Use:

- Only DOI members, authorized instructors, or students during classes taught by authorized instructors.
- All dogs on premises must be current on vaccinations, as recommended by their veterinarian.

Safety First:

- Do not allow your dogs on the equipment unless you are taking or have taken agility classes and know the safe way to train your dog. DOI is not responsible for injuries incurred from use or misuse of the equipment.

Aggressive Dog Policy:

- Dogs that are aggressive toward other dogs or people are not allowed in any classes on DOI fields. Dogs deemed to be aggressive will be asked to leave the premises.
- Handler is responsible for the dog at all times.

Ring Use:

- Only one dog off leash in a ring at a time. Other dogs must be under restraint and supervision of owner (i.e. leash, crate, x-pen, owner's arms, etc.). If a dog is tied out, it must be at least 10 feet from the agility rings. If a dog is left in a vehicle, it must not be able to leave the vehicle.
- If more than one person is present, practice no more than 10 minutes per person and take turns.
- Only Dog-On-It equipment may be used. Equipment rented to another instructor may not be used by members except in that instructor's classes.
- Pick up after your dogs and dispose of your trash. Dogs should not eliminate in the agility ring or on the equipment. Clean any equipment that is soiled. Discard trash and dog waste in the trash can. This applies to anywhere on the premises, whether inside or outside of the fenced area.

General NOCIA rules:

- No overnight parking or camping **[other than permitted RVs or tents at a show or match]**.
- To create a healthier environment, please refrain from smoking or drinking alcoholic beverages in or near the agility field.
- No open fires permitted on the premises at any time.

- No sustained loud noise after 11:00 PM.
- Everyone must comply with state, county, and municipal laws and ordinances.

When leaving the field:

- All contact equipment should be left in a usable condition at minimum of 10 feet away from the fence line.
- Turn off lights.
- Turn off water faucet if turned on, and empty puppy pool.
- Make sure trash is disposed of properly.
- VERY IMPORTANT: Lock our gate to practice field. **Make sure locks are attached so opening either will open the gate.**

Non-members:

- Club members may bring the same guest twice in one year at no cost, but after that, the guest will be required to join the club if they would like to continue to use the field for practice. **In any circumstance, visitors must sign a release.**

Enforcement:

- Any violations of the club's policies should be reported to the Board of Directors. Members who violate these rules may have their field privileges revoked without refund.

Release of Liability and Hold Harmless Waivers

COVID Waiver of Liability and informed Consent:

- An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. By visiting this facility, you voluntarily assume all risks related to exposure to COVID-19.
- By signing this waiver I fully attest to the best of my knowledge that I do not have COVID-19 at the time of attending this class, ring rental, event, or visiting the property for any reason. Nor have I been in contact with or exposed to any known carrier of COVID-19 within the last 15 days. I agree that I am visiting the Dog-On-It Agility Club class, ring rental, event or for any other reason entirely at my own risk and take full responsibility for my own health and safety during this attendance. I will follow all Dog-On-It Agility Club rules and requirements to reduce any exposure and possibility of contracting or spreading the virus. I will also fully cooperate with any City, County or State guidelines applicable to the area where the class, ring rental, or event is taking place. I ALSO AGREE THAT IF I TEST POSITIVE FOR COVID-19 IN THE FUTURE I WILL INFORM DOG-ON-IT AGILITY CLUB BY EMAILING THE CLUB OF MY POSITIVE TEST RESULT. I agree that the Dog-On-It Agility Club as well as its Board Members, Training Directors, instructors, assistants and volunteers, are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, before, during or after this class, ring rental, event, or any visit to these premises. I hereby waive any legal claims against the aforementioned organization and individuals, including any claims for negligence, failure to warn, or any other claims for damages or personal injury. Any exposure to COVID-19 involving myself, the location other participants or spectators, or animals on the premises will be my sole responsibility. I assume all financial liability for myself, and I will pay any financial costs associated with my actions
